This combined Current Report on Form 8-K is being filed by Great Plains Energy Incorporated (Great Plains Energy) and Kansas City Power & Light Company (KCP&L). KCP&L is a wholly-owned subsidiary of Great Plains Energy and represents a significant portion of its assets, liabilities, revenues, expenses and operations. Thus, all information contained in this report relates to, and is filed by, Great Plains Energy. Information that is specifically identified in this report as relating solely to Great Plains Energy, such as its financial statements and all information relating to Great Plains Energy's other operations, businesses and subsidiaries, including KCP&L Greater Missouri Operations Company (GMO), does not relate to, and is not filed by, KCP&L. KCP&L makes no representation as to that information. Neither Great Plains Energy nor GMO has any obligation in respect of KCP&L's debt securities and holders of such securities should not consider Great Plains Energy's or GMO's financial resources or results of operations in making a decision with respect to KCP&L's debt securities. Similarly, KCP&L has no obligation in respect of securities of Great Plains Energy or GMO.

Item 8.01 Other Information

As discussed under Management's Discussion and Analysis - Executive Summary - KCP&L Kansas Rate Case Proceedings in the Quarterly Report on Form 10-Q for the quarterly period ended September 30, 2012, on April 20, 2012, KCP&L filed an application with The State Corporation Commission of the State of Kansas (KCC) to request an increase to its retail revenues of \$63.6 million, with a return on equity of 10.4% and a rate-making equity ratio of 51.8%. In September 2012, KCP&L revised its requested return on equity to 10.3% and increase in retail revenues to \$56.4 million. On December 13, 2012, the KCC issued its order (KCC Order) which authorized an increase in annual retail revenues of \$33.16 million, reflecting an authorized return on equity of 9.5%, an equity ratio of approximately 51.82% and a Kansas jurisdictional rate base of approximately \$1.798 billion.

The rates established by the KCC Order will take effect on January 1, 2013. Parties to the case may file petitions for reconsideration with the KCC by December 28, 2012 and may also file court appeals. However, the rates authorized by the KCC Order will be effective unless and until modified by the KCC or stayed by a court.
